Prices

Purchasing

- 1. Accepted forms of payments include Visa, Mastercard, or Discover through our website checkout process.
- 2. We accept purchase orders with EFT payments from schools with active accounts. Please contact <u>sales@newmettlefarms.com</u> to open and maintain your account activation.
- 3. We accept student schools from schools where New Mettle Farms is an approved vendor. Please follow your school instructions for the use of these funds.
